### Supplement

### SYNOPSIS:

On the morning of January 28, 2008 at a approximately 0630 during breakfast inmates Richard Glatzer #208942 and Jose Garcia-Jauregui #207456 were involved in a fight in the Solitude 3 Dayroom. After investigating the incident it was determined that inmate Garcia-Jauregui was the primary aggressor. One count of assault on a prisoner by a prisoner against Inmate Garcia-Jauregui will be referred to the Utah County Attorney's Office for review and filing.

#### NARRATIVE:

At approx 0630 I was having the inmate workers in Sol 3 pass out the breakfast trays to the inmates in Sol 3. As dorm 11 came down to get their trays I heard two inmates arguing and then noticed the two inmates fighting. At the same time I came out from behind my desk Deputy Robinson came over from Sol 2 and called for backup while I pressed my Duress Alarm. The rest of the inmates were told to rack in and Deputy Robinson gave a verbal command for two inmates to separate. Neither inmate attempted to separate from the other so Deputy Robinson grabbed Garcia and pushed him away to separate him and at the same time I detained Glatzer and had him kneel down. At this time backup arrived to assist.

#### INTERVIEW WITH GARCIA:

Inmate Garcia stated to me that last night (1/27/08) he went up towards dorm 11 to give "the guy with a tattoo on the back of his neck" (inmate Hamel) a hard time for being rolled up from the OUT program. He stated that Glatzer, who was also rolled up from the OUT program, said to Garcia "what the fuck are you looking at?" and then he pulled his pants down and said " do you want to suck on this?" Garcia told me that he felt disrespected because of what Glatzer did but it was right at 2200 hrs so the unit was on lock down for the night. He stated that he thought about it all night and was just going to let it go until Glatzer "walked hard" towards him at breakfast and he was not going to be disrespected like that. (See Voluntary Statement)

### INTERVIEW WITH GLATZER:

Inmate Glatzer stated to me that he was "sucker punched " by Garcia. He told me that he was walking up to get his tray and he had his head down looking at his tray and when he walked over to Garcia (who was an inmate worker) to get a banana he was punched in the face. He then stated that he "kicked Garcia and he got in a couple of punches, one to his arm and another to his face". When asked why he would be sucker punched like that, he stated that ever since he was rolled up Garcia had been staring at him and so he asked him what he was looking at.

#### MEDICAL:

After the incident Inmate Glatzer was taken to medical to be checked out by the nurse. He had Private Medical . He was left in medical for a

couple of days for observation.

#### ACTION TAKEN:

Due to the fact that Inmate Garcia initiated the confrontation with Inmate Glatzer by striking him in the face, one count of assault on a prisoner by a prisoner will be referred to the Utah County Attorney's Office for review and filing. It should be noted that inmate Garcia has pending charges of attempted murder with injury and aggravated assault out of the 4th district court.

## Supplement

January 28, 2008

On the above date and about 0630 hrs Inmates were serving breakfast in Sol 3, Deputy Jarvis was the deputy on duty and I was sitting at the desk in Sol 2 while the Sol 2 Inmate workers were finishing serving breakfast also.

I heard a noise that got my attention from Sol 3 and I Noticed two inmates later discovered to be Jose Garcia-Jauregui#207456 and Richard Glatzer#208942 they were squared of towards each other and began to engage in a physical altercation.

I noticed that Deputy Jarvis didn't notice them yet so I began to yell for them to knock it of. I also called for backup and yelled for all inmates to rack in. Both inmates continued to wrestle around and I noticed inmate Garcia-Jauregui strike Glatzer in the face. I approached the inmates and ordered them to stop and they did not. I grabbed inmate Garcia and Pulled him away from Glastzer yelling again for them to stop. Deputy Jarvis also grabbed Inmate Glatzer. I forced Garcia-Jauregui to the ground and held him there telling him not to move. Backup Deputies arrived and assisted hand cuffing both inmates from the section without further incident.
