I responded on a report of a single vehicle accident on Wyatt Earp Ave., in Eagle Mountain. No injuries reported.

On January 30, 2014 at 0858 hours I was dispatched to the area of Wyatt Earp Ave., in Eagle Mountain on a report of a single vehicle accident. It was reported there was an Alpine School bus that had hit some mailboxes. There was children on the bus at the time of the accident and had been removed and put onto another bus. No injuries

CONTACT WITH THE DRIVER:

I made contact with the driver, June Powers, who said around 0850 hours she had turned around in the cul-a-sac at the south end of Wyatt Earp. She started down the snow packed hill when the passenger side of the bus started to slide to the right. June tried to correct the slide by turning the bus left. The bus continued to the right hitting two mailboxes.

June said she had six special needs children on the bus at the time of the accident. All of them had been removed from the bus and loaded onto another bus, before my arrival. There was no injuries reported.

The vehicle is a yellow 1994 Bluebird school bus. Utah license plate [Unwarranted] Bus number [Unw]. The damage to the bus was minor and occurred on the passenger rear fender.

Both mailboxes were destroyed and contact with the owners was made. Micah Jessup who lives at the residences of [Unwarranted Invasion of Personal] was talked to. The residences at [Unwarranted Invasion of Personal] is vacant. Contact with the real estate company, American Homes, was made.

Contact with the driver was made and photo's taken. Driver contacted her employer and drove the bus from the scene. No further action taken.

On February 7, 2014 I made contact with Micah Jessup who said that Alpine School had replaced both mailboxes and post.
