11/16/2013 - 21:40

-SYNOPSIS-

Juvenile cited for criminal mischief and domestic assault for pushing her father down the stairs and punching holes in the walls of their residence.

-DISPATCH-

On 11/16/2013 I was dispatched to 632 E Pioneer Rd. for a domestic in progress.

-INITIAL CONTACT-

When I arrived on scene I saw a juvenile, Meagan Grunwald [REDACTED] outside the residence talking on her phone. Meagan was very aggravated, pacing around and crying as she talked. Her mother, Tori Grunwald [REDACTED] was also outside and informed officers her husband, Jerry Grunwald [REDACTED] was still inside the home. I conducted interviews with Tori and Meagan while Sgt. Newman and Sgt. Coe made contact with Jerry.

-TORI-

During my interview with Tori she told me Meagan had been arguing with her father about Meagan's friend, Jose Garcia [REDACTED]. She reported Jerry didn't like the age gap between the two and wanted Jose to leave. This angered Meagan and a verbal altercation began with her father Jerry. Tori reported Jose stating he was just going to leave to diffuse the situation, but this caused Meagan to become more violent and she started punching holes in the walls of the residence. Tori told me after Jose left Meagan ripped the screen off the front door and pushed Jerry down the front steps. Tori was unable to give any further details.

-MEAGAN-

When I interviewed Meagan she told a very consistent story to Tori. She told me her and Jose were watching a movie and she got sick of Jerry checking on them. She reported she began to argue with her father about whether Jose should leave the residence. Meagan reported when she heard Jose say he was going to leave she freaked out and began punching holes in the walls. Meagan also told me this was not the first time something like this happened and after Jose left she was so mad at her father she pushed him causing him to fall down the steps of their front porch. On her way back into the residence Meagan told me she ripped the screen out of the front door. Through out the incident Meagan was very confrontational with officers and to be calmed down on several occasions. Meagan also had some swelling to her right hand and knuckles, but refused to be seen by fire.

-JERRY-

During an interview with Jerry, he gave officers a very similar outline of what had happened. Jerry did not want to fill out a witness statement, but did volunteer to leave the residence for the night to help deescalate the situation. I explained to Jerry since he was the home owner and he did not commit a crime, he did not have to leave, but I did agree with his decision due to Meagan still being upset with him. Jerry left the residence with no further incident.

-JOSE-

Jose had already left when I arrived, but returned to the scene to fill out a witness statement. He told me the same story as the other involved parties. Jose said Jerry had hinted in the past about him needing to leave the residence, but had never told him to go. He said when he saw the trouble it was causing to have him there tonight he decided to leave. He also confirmed the reports of Meagan being the primary aggressor during the incident and of her punching holes in the walls of her parents home.

-ACTIONS-

After conducting interviews I determined Meagan to be the primary aggressor of the incident. I cited Meagan with SS Assault Domestic 76-5-102 and Criminal Mischief SS 76-6-106. Meagan was informed she could be arrested if officers had to return to the residence later due to her outbursts and behavior. Both Jerry and Tori were informed of the citations. Meagan was released to her mother's custody. No further actions were taken.

-EVIDENCE-

Photos of the incident were taken by Sgt. Coe and downloaded to as digital evidence to the department N drive.

NEWMAN

November 16, 2013 at approximately 2140 hours I was dispatched to 632 E Pioneer Rd to assist Officer Sullivan with a domestic dispute in progress.

Sgt Coe and I arrived at the same time and make contact with Meagan Grunwald, she was emotional and did not know where her father Jerry was at. A short time later Tori Grunwald exited the house and I asked Tori where her husband Jerry Grunwald is at and she said she thinks he is inside the house possibly in the bedroom. Tori said we could go inside the home and talk with Jerry.

CONTACT WITH JERRY

When I entered the garage area I noticed the garage man door to the house was approximately half way open. Not knowing exactly where Jerry Sgt Coe and I slowly entered the residence. I called out several times to Jerry and identified myself.

I located Jerry in the master bedrooms bathroom with the door closed. I talked to Jerry for a moment with the door closed. Because I know Jerry from other calls I was able to talk him into exiting the bathroom and talking to me.

Jerry was upset police was at the home at first and he thought he would be arrested for something because his wife and daughter always make him look like the bad guy. Once I was able to calm Jerry down and assure him we would investigate the incident thoroughly and not simply arrested him without cause Jerry opened up and told me what occurred tonight.

Jerry said Meagan is 17 years old and wants a 26 year old man to move in with him and his wife Tori. Jerry said he is not comfortable with a 26 year old man staying at his house with his daughter but Tori believes it will be ok for the man to move in.

Jerry said Meagan and her boyfriend was hanging out in Meagan's room, he voiced his concerns which didn't seem to matter to anyone else in the home. Jerry said Meagan's room door was shut so he periodically opened the door and checked on them making sure they wasn't doing anything else he didn't approve of, after he did this a couple times Meagan got extremely upset and started screaming at him.

Meagan exited the room cursing at Jerry then she punched the sheet rock wall near her room causing extensive damage and several holes in the wall. Jerry said Tori sided with Meagan so he left the area in his wheel chair to avoid the situation escalating further.

Jerry mentioned at one point Meagan pushed him down some stairs but he would not tell me anything else about the push. Jerry said he just wants to leave the home for the night and he does not want Meagan arrested or charged with anything. Jerry did not want to fill out a voluntary witness statement.

I spoke with Officer Sullivan and explained what Jerry told me, Officer Sullivan told me Jerry's explanation of events is the same as Tori and Meagan's.

I stayed with Jerry while Officer Sullivan investigated the incident. When Officer Sullivan told me he was going to issue Meagan a citation for domestic assault and Jerry could leave if he wanted I relayed the information to Jerry. Jerry told me he understood why Meagan was being issued a citation but he did not agree with it. Jerry got some clothing and other essential items then left in his pickup truck.

TORI

While Jerry was getting ready to leave I spoke with Tori briefly. Tori asked me how she can get a restraining order against Jerry for his actions tonight. I asked her what she meant, Tori said she believes this incident only occurred because of Jerry and she thinks it is his fault. She said she understands why Meagan got upset and punched the wall and again thinks it is all Jerry's fault.

I told Tori because Meagan is a juvenile and Jerry is also her parent he has the right to refuse allowing an adult man stay in their home with Meagan. Tori said she doesn't see why this is an issue because Meagan is a good person and would not do anything with the man. I again explained to Tori that Jerry also has parenting rights. Tori said she understood but doesn't agree.

I told Tori that Jerry wants to leave for the night. I explained to her that because Jerry lives at the home he can return whenever he wishes to. I asked her to contact police if Jerry returns and they cannot be civil with each other.

JERRY LEAVING

I spoke with Jerry again as he was preparing to leave for the night. I explained to Jerry that he was not being asked to leave and that he can return if he wishes. I also asked him if he does return and they cannot be civil to contact police.

No further actions taken by me.
