Officer Herbert and I were the first to arrive. Officer Deutsch arrived right after us. We walked toward the open garage of the house. I heard music in that location, so I lead as we approached. I saw Tori Grunwald in the kitchen window and pointed it out to Officer Herbert. We were in the garage and knocked on the door into the house. Jerry Grunwald exited the home running and jumped on his motorized chair to leave. He was forcefully stopped from leaving and would not stop with a simple command. He verbalized that he was angry and he had a gun pointed at him and he was going to find Angel Garcia and take care of it himself. Officers had to keep stopping him from leaving in a rage to take what appeared to be revengeful action.

Jerry Grunwald refused to make a written statement and stated that he could not read or write. He did talk to some degree while I and Officer Herbert videoed his statement, but he also refused to tell complete details. Overall, he stated that he was angry at Angel Garcia because he was 26 years old and having sex with Meagan, who is 17 years old. He confronted Angel because of the age difference and Angel pointed a gun at Jerry and verbally threatened to kill him. Jerry would not describe the gun and refused to give any information about it. He made some statements about an airsoft and other statements about a .22 caliber. He never clearly explained this situation or threat.

I asked Jerry how he knew that Angel was having sex with Meagan. He only stated they were both sleeping in Meagan's bedroom. He had nothing more to offer for his claim.

Jerry claimed he slammed his daughter and pushed his daughter and wife. He stated it was in self defense.

Meagan stated she heard her mother, Tori, and her father, Jerry, arguing. She asked her dad to stop fighting and Jerry threatened that he would have her taken to jail. Jerry stated that Angel was a child molester. He was very argumentative. Jerry tried to hit Angel and Angel was trying to leave the home. Meagan said she was protecting Angel from her father and pushed Jerry away from Angel. Jerry slapped Meagan on the face and she left to go to the kitchen. Jerry followed and hit Meagan on the right side of her head. Jerry tackled Meagan to the ground and put his hand around Meagan's neck. Meagan got away from Jerry and put Jerry in a head lock. Meagan continually asked Jerry to stop fighting throughout the situation. Jerry told Meagan to get her stuff and leave the house. Meagan started packing her stuff and Jerry came into her room and was yelling at her. Jerry then walked out of Meagan's room and confronted Tori, his wife. Meagan witnessed Jerry put his hand on Tori's shirt. Meagan told Jerry to take his hands off her mother and she pushed Jerry again. Meagan open the door and Jerry hit Meagan's head against a wall. She stated they were fighting and her dad, Jerry is crazy. She stated that her father cannot read and write, so she has had Angel help her with college level classes. She stated that she stays in a spare room and Angel stays in her room. Meagan also claimed that her father walks around the house all the time naked. She stated that she understands the house is his, but she does not like it.

Tori had the same basic story about the fight as Meagan. Tori explained that Jerry was following her around the house while she was trying to get away from Jerry. Tori and Jerry were in an argument because Jerry thinks Angel is a child molester. Meagan confronted them because of the argument. Jerry started calling Meagan names and Angel was trying to leave. Jerry and Meagan started fighting and Jerry pushed, hit and knocked Meagan to the floor. Angel left the home. Jerry had Tori's phone and would not give it to her. She got the phone and called "911" and hung up because she could not hear anything due to the yelling and screaming. It appeared through their accounts that they were trying to protect Angel from Jerry. Tori did not see a gun and did not have any information about one. Tori felt that Jerry was jealous of Angel because Meagan has a better relationship with Angel than her own father. Tori was questioned about Jerry walking around in the house and Tori stated that Jerry walks around in his underwear only.

I spoke to Angel on the phone. He refused to return to the address to give a statement. He stated he ran out of gas on the 3100 South block of State Street. I requested South Salt Lake Police to go to the location to find Angel. I had advised Angel that we would come to his location and he agreed. He then stated his phone was dying and I was disconnected from him. He was not located by South Salt Lake Police. Meagan advised me that Angel has recently gotten out of prison. According to her, he was convicted for manslaughter. According to Jerry Angel was not suppose to have a gun so that is why he left.

I attempted to arrest Jerry for the DV-Assault charges. I got one hand secured and he jumped from his wheelchair and tried to get away. I pulled him to the ground and he then submitted to arrest.

Jerry Grunwald was arrested, booked, issued a citation and a no contact order for Domestic Violence - Assault for two counts and for Resisting Arrest.

### NARRATIVE

SUPPLEMENTAL HERBERT

PHYSICAL DOMESTIC / ARREST

632 E Pioneer Road

I responded to a physical domestic violence call at the Jerry Grunwald residence with Officer Braegger and Officer Deutsch.

When we arrived Officer Braegger and I positioned ourselves just outside the back door inside the garage. The radio was on inside the garage and was loud, making it difficult to hear what was going on inside the home.

Officer Braegger knocked on the door. Jerry came bursting out of the door, screaming that he was leaving and said numerous times he did not have to stay. I told him he did have to stay. He jumped into to his automatic wheel chair and tried to flee out of the garage. We were able to stop him physically and with verbal persuasion. He stated saying that Meagan's boyfriend (who resides in the home) pointed a gun at him. We asked him several times to give us information. He declined he said he would take care of it himself, He said he was going to kill him.

Jerry ordered me off of his property because I was a Mexican. He said that he hates Mexicans and he was not going to speak to me.

He asked at one point if we were going to go find Angel. We told him if he would give us any information we would look for him. He said I am not going to, I will take care of him myself. This was stated several times by Jerry.

Later we were able to identify the boyfriend as Angel Garcia. He is said to be on parole for manslaughter. The vehicle description given to us was a white Cadillac passenger car.

Officer Braegger went inside the home to interview Meagan and Tori Grunwald. Meagan is the seventeen year old daughter of Jerry and Tori.

Officer Deutsch and I stayed with Jerry while he was sitting in his wheel chair. He made statements while he was sitting in the chair, he said why don't you arrest me for child molestation and abuse. He put out both his arms as if to have him handcuffed. I advised Jerry that he was not under arrest at this time. Officer Braegger would be out of the home after he interviewed Tori and Meagan. He said, well you always will side with the women, so you might as well arrest me now. Jerry told Officer Deutsch and I he was glad a Draper Officer was shot and killed, he wished that more officers would have been killed.

Officer Braegger came out of the home. I spoke with Officer Braegger in private, It was determined that Jerry was the predominate aggressor. We walked back over to Jerry, Jerry told Officer Braegger to arrest him. Officer Braegger brought out his wrist restraints, and told Jerry he was under arrest. He also asked Jerry if he was going to cooperate. He said he would. Officer Braegger placed one cuff of the wrist restraints on Jerry's right wrist. Jerry burst out with anger and attempted to resist and stand up from the wheel chair.

Officer Bragger was able to maintain control of Jerry from behind. Officer Deutsch and I attempted to gain control of Jerry's right arm. The decision was made to lay the wheel chair down on the side to gain control of Jerry. The wheel chair was rolled onto the right side and Jerry exclaimed that he gave up. He became compliant and was double cuffed due to his large stature. Officer Bragger assisted him to sit up and we walked him over to a conventional wheel chair, conducted a search incident to arrest on Jerry's clothing and placed him in the back of Officer Braegger's patrol vehicle.

I removed Jerry from the car to adjust his wrist retains, He was complaining about pain. I was able to adjust them and asked him if it was better, He said yes. We placed him back into the patrol vehicle.

Officer Braegger took Jerry to the Salt Lake County Jail.

Officer Braegger asked us to issue a Domestic Violence Pamphlet to Tori and Meagan. Officer Deutsch obtained the pamphlet and I explained the pamphlet and resources available. I also gave instructions on obtaining an Ex Parte Protective Order.

Officer Deutsch took photos of Meagan and Tori. Meagan showed us her neck and the left side of her face where Jerry had struck her. Her neck was pink and the left side of her face appeared red and slightly swollen.

We also advised Tori and Meagan to have Angel Garcia contact us and his parole officer as soon as possible.

On 01-11-14 Officer Braegger, Herbert and I responded to a domestic disturbance at the residence of Jerry Grunwald. Jerry is known to police and is very anti- police. I arrived and Officers Braegger and Herbert were making contact with Jerry Grunwald in the garage. Jerry was very agitated and yelling. He was very confrontational with officers and called Officer Herbert a Mexican several times saying he hated Mexicans and to get off his property. Officer Herbert and I stayed with Jerry outside while Officer Braegger went inside to speak with Jerry's daughter, Meagan Grunwald and his wife, Tori Grunwald.

I was asked to give Tori and Meagan a witness statement to fill out. I got the statements and knocked on the garage door to give them the statements. Meagan came to the door, she was visibly upset and said she was having trouble breathing. Meagan said her dad had slapped and grabbed her by the neck I contacted dispatch and had them call medical to evaluate Meagan. They came and checked her out and left stating there was nothing wrong other then she was just upset from the situation.

Officer Braegger came outside and Jerry said I know you're going to arrest me and extended his arms out. He then asked what happened to Angel. When he was told we have not been able to find him he said oh, I am getting mad and he began to resist officer Braegger I assisted officer Braegger. We grabbed Gerry, removed him by tipping his chair to the side, and placed him on the ground as he continued to resist us. I grabbed his left arm and pulled it around to his back where Officer Braegger was able to handcuff him.

Jerry was transported to the Salt Lake County Jail and booked into jail.

Officer Herbert and I were asked by Officer Braegger to give Meagan and Tori a domestic violence pamphlet and to photograph their injuries. I gave a pamphlet to them and photographed them. Meagan said she was trying to protect her Mom from Jerry. Meagan said she shoved Jerry away from her Mom as he was grabbing her. Meagan said Jerry then slapped her several times grabbed her by the throat and threw her to the ground., I took pictures of Meagan's face and neck. Tori said she did not have any injuries. I photographed her showing she did not have any apparent marks or injuries. There were no marks on Meagan's neck but her face was red. I don't know if the red face was a result of an assault or her excited state.
