On 12/5/2013, Garcia transfered his parole to Salt Lake City as he worked in Draper. He first reported to the AP&P office in Salt Lake on 12/10/2013. Garcia moved in with friends [REDACTED]. On 1/11/2014, Draper PD was called out on a report of a domestic violence case at the [REDACTED] home. Garcia and [REDACTED] got into an altercation after [REDACTED] accused Garcia of having sex with [REDACTED] his seventeen year old daughter. [REDACTED] accused Garcia of pointing a gun at him before he left the scene before the police arrived. [REDACTED] refused to tell complete details of the case. He would not describe the gun to give any information about it. He made some statements about an air soft gun and a .22 caliber. He admitted to slamming his daughter and pushing her and his wife. [REDACTED] denied she was having sex with Garcia and stated he was helping her with some college level classes. She indicated they sleep in seperate rooms.

The officer contacted Garcia by phone and requested he come back to the house. He refused to return to the address to give a statement. He stated he ran out of gas on the 3100 S. block of State Street. South Salt Lake PD was called and could not locate Garcia.

[REDACTED] was arrested for DV-Assault charges. He was issued a no contact order for two counts of Domestic Violence-Assault, and for resisting arrest.

Garcia reported on 1/14/2014, and was confronted about not reporting police contact and not living at his residence of record because he has been staying at the [REDACTED] the past few nights. He admitted getting in to an argument with [REDACTED] but denied pointing a gun at him or having possession of any firearm. Garcia was told he would have to find another place to live as he is not allowed back at the [REDACTED]. He agreed moving back to his brothers in Provo. A call was placed to his brother at the office and he approved Garcia moving back there. Garcia reports he is still employed at [REDACTED] but has been off for a few weeks due to a concussion he received when he ran into a door while playing with a dog. I attempted to verify his employment but was un able to as all I got was an answering machine. Garcia was instructed to report to the Region 4 office the following morning. The case was forwarded to Detectives to review for possible sex and weapons offenses of Garcia. The Board was notified of the incident and an alternative event was requested for failing to notify a change of address and for not reporting police contact.
